Edgar Allan Poe’s works are frequently analyzed for their psychological complexity. Poe’s statement, “All that we see or seem is but a dream within a dream,” reflects the Romantic fascination with perception and illusion. Nathaniel Hawthorne’s symbolic approach, especially in *The Scarlet Letter*, has been interpreted as a critique of moral absolutism.

Overall, the literature demonstrates that American Romanticism is not only an artistic movement but also a philosophical framework that shaped national identity, emphasizing subjectivity, emotion, and the symbolic power of nature.
