From time immemorial, the composition was understood in close connection with the idea of the work. composition is not just a structure of the work, but the purpose of this structure, on the basis of what it is. Only in some cases, in particular, in some Chronicle plots, as well as in plots based on the dynamics of the "internal movement", it may not seem exaggerated enough. The knot is usually given at the beginning of the work, after the exposition. Sometimes, with the aim of a certain artistic and aesthetic goal, its role is also changed (for example, in the novel "Days Gone By", Athabek was met with a tambourine of Silver — the knot of the work, but this story is told at the end of the first half)

That is, the non-existence of a literal solution becomes a method that serves to increase the power of influence of the work, the creative activity of the reader. For Example, P.Kadyrov's "Erk", O.Yakubov's "Matluba", "The Wing will be a pair", X.Sultanov's stories such as "the coast of Bliss" face the same situation. So it will be more correct to understand the solution not as a solution to the conflict posed in the work, but as the end, result of the development of events in it. The "mysteriousness" in the narration increases another *bahya* when the reader observes the behavior of Silver, its thoughtfulness-glazing with water from the *yu* ditch, their babbling at the girls ' meeting. Finally, Silver's "is that you?" when he hears the words full of admiration, the reader is sure that his guess in his language has come out correctly, and the moment he is satisfied, the writer also opens the word from that random meeting. We see that simply this method increases the creative activity of the reader, brings him closer to the psyche of the heroes, increases the power of influence on the charm of the work. The method seen in the example of "Days Gone By" is called retrospection, the essence of which is that the writer stops the events of the plot and moves to the past, to the image of events that took place earlier. While the Almighty used this method only in one place of the novel, retrospection occupies a leading position in the plot construction of some works, in which the past is alternately given by the artistic time of the work. For example, M.M. Do stning. First of all, it is necessary to distinguish between the time of occurrence of the events described in the work of art and the time of their narration. If we conditionally take the time of the occurrence of events in the work as "plot time", the time of the narration of the events of the work as "composition time", then it is seen that these two do not always coincide. Because the writer, working on the work (epic works are meant in this place), can use the possibilities of "artistic time" in different ways on the way to the realization of his creative intention. Suppose that in a necessary place he can retreat from the time of the work and describe events that have occurred in the past ("retrospective time"), respectively describe events that coincide at one time in terms of their occurrence ("parallel time" — this is taken in relation to the main plot line). The fact that the events in the plot of the work formed the illusion of continuity in the reader's imagination (therefore, when we talk about the events of the plot, we say "then this will happen", "so much vaq, For Example, S. In the novel "slaves" by Ayni, events that have passed for more than a century, and in "Scorpion from the altar" - for only about six months, are taken to the pen. Nevertheless, these two novels do not differ much from each other in terms of volume (or time of narration) (in proportion to the time described in them). After all, in the "slaves" built on the basis of the Chronicle plot, the time of composition extended at the expense of the length of the time of occurrence of events, while in the "Scorpion from Mehrab" based on the concentric plot, it expanded at the expense of retrospective and parallel times. So, artistic time is a conditional concept, this conditionality arises with the requirement to fit the plot time into the framework of the composition time. Since the plot of a work of art is composed of events, and events are composed of the actions, mutually complex relationships, contradictions of the characters, it is also defined as a system of events that generalize life conflicts. Between the plot and the conflict, a dual connection is observed: on the one hand, the plot, Conflict (lot. conflict) is understood as the mutual struggle of the characters of a work of art, the conflicts of the hero with his environment, as well as the contradictions that pass in his psyche. The bar of conflicts that exist in the real life of a person is reflected in it artistically, both because the work of art reflects reality artistically, and in its
